This certification covers the entire Tebubio group (our 9 European offices and our laboratory near Paris) and all our activities ("Sales of reagents and services for biological research").

Through our QEMS, which is fully integrated into our organization, we are committed to maintaining a culture of quality and excellence throughout our operations, from sourcing and distribution to customer service. Our approach places our customers and our stakeholders at the center of our activities. Their satisfaction is key to our shared success.

Our teams are trained to uphold these standards, and we encourage a continuous improvement mindset at all levels of our organization. Our approach includes optimizing our supply chain for greater sustainability, favoring eco-friendly packaging, and promoting green initiatives within our facilities. To address the pressuring urgency of global warning we have also joined the French Decarbonation Alliance to reinforce our greenhouse gas reduction program and ultimately improve our ecological footprint. We are also promoting biodiversity at our sites by dedicating some of our French grounds to wildflower gardens and installing beehives in these preserved gardens.

Tebubio and its members will not offer, give, or accept any valuable gifts, under any circumstances.

We strongly believe that research should be conducted in compliance with the highest ethical standards to prevent harm in achieving progress.

Biotechnology is advancing at rapid pace and may one day put an end to the use of animals in research. Until then, Tebubio contributes to the phasing out of animal use by helping our customers find alternatives to animal experiments in our services and products. In particular, we provide technologies that enable *in silico* and *in vitro* studies while limiting animal testing

and clinical trials. Where we find no alternatives to animal products, we uphold our suppliers to animal welfare standards that often exceed applicable laws, through our Bioethics Policy, and we hold all regulatory permits for products subject to the Convention on International Trade in Endangered Species (CITES).

We also ensure that all Human Biological Samples we provide have been collected in full compliance with ethical requirements, and therefore we are in possession of all donor details and all necessary permits and authorizations.

Through our products and services, we contribute to the great scientific community every day. But as members of society and many other communities, we at Tebubio also consider other communities that live and evolve around us and our commitment to CSR extends beyond our business operations. Tebubio is committed to making a positive impact on the local and global communities. That is why we pay special attention to our partners, our neighbors and all those who cross our path.

As we ambition to be sustainable in all aspects of our activities, we have placed CSR in the heart of our strategy. As a result of all the actions we have implemented as part of our CSR policy and for many years, Tebubio was awarded the Ecovadis Bronze Medal in November 2024.
